

Primary Agricultural Societies Grant Program Guidelines

The Agricultural Societies Grant Program provides a base grant as well as partial reimbursement of eligible expenses from a society's previous year of operations (as the total expense claimed by all societies exceeds the total grant funding available).

There are four sections in which an agricultural society can receive grant funding:

- (1) Governance, Leadership and Training Expenses (Section 1);
- (2) Agricultural Activities and Programs Expenses (Section 2);
- (3) Operational Expenses (Section 3); and
- (4) Base Grant (Section 4)
- To be eligible to receive a grant you must either operate a facility or run an agricultural event/program and be in Good Standing under the *Agricultural Societies Act*.
- Expenses paid or reimbursed by another organization are not eligible (e.g. municipal operating grants must be deducted from your operating expenses).
- All expenses claimed must be paid by the agricultural society and be captured in your year-end financial statements. Supporting schedules, copies of ledgers, or statement of expense templates (see Appendix D) can be used to detail and support your claim.
- Financial statements must be an audit report or a review engagement report prepared by a professional accounting firm.
- The donated use of your meeting rooms is captured in your utility costs in Section 3,
 Operational Expenses. Do not claim again.
- Names of camps, conferences and courses must be provided. The general term "donation" is not allowed.
- Travel within Canada only.

Appendix C – Eligible Expenses (for Section 3 Template)

**Items directly related to holding an Agricultural event/activity such as advertising, postage, freight, highway signs, supplies, etc. can be claimed in the activity expenses and should be detailed.

Appendix D – Eligible Operational Expenses This funding pool is intended to support some of the most major expenses agricultural societies commonly incur with the operation of their facilities. It does not support new construction or major renovations, nor is it intended to fund all of your operational costs (you are free to use your base grant towards other expenses). Eligible expenses should be readily captured on your financial statements (insurance, utilities, repairs and maintenance and wages).

SECTION FOUR - BASE GRANT

As long as the expenditures fall within the objective of agricultural societies as defined in the *Agricultural Societies Act* (to encourage improvement in agriculture and enhanced quality of life for people living in the community), you are broadly free to spend these funds as you see fit by developing educational programs, events, services, and facilities based on the need of your community. The total operational spending of your ag society must exceed the base grant each year.
