

# 2024 Deer Hunters

## Assist Us With Our CWD Surveillance

The ongoing Chronic Wasting Disease Surveillance program for 2024 targets the following wildlife management units (WMUs).

Submission of deer heads is:

- Mandatory any deer:** WMUs 148, 150, 151, 200, 234, 236, 728, and 730
- Mandatory mule deer and voluntary white-tailed deer:** 503, 504, 505, 506, 509, 510, 514
- Mandatory mule deer only:** 108, 110, 212, 216, 221, 224, 246, 247, 248, 250, 300, 302, 303, 306, 308, 310, 312, 314, 316, 320, 334, 402, 404, 508

**Precise location of each kill is required, either GPS or Sec/Twp/Rng, in addition to the WMU.**

Our **CWD-labelling system** provides a unique identification number for each head submitted. Heads should be frozen and, during rifle seasons, can be dropped off at any of the freezer locations indicated herein. Some Fish and Wildlife or Environment and Parks offices also may accept frozen heads. Hunters are advised to call ahead and make arrangements. Check page 13 of the *2024 Alberta Guide to Hunting Regulations* for office phone numbers. Green CWD labels and instructions are available when you submit the deer head. **PLEASE DO NOT REMOVE EXTRA LABELS FROM OUR FREEZERS. TAKE ONLY THE LABELS FOR THE HEADS YOU ALREADY HAVE.**
