Iyadoo loo marayo hannaan wada-shaqeyn ah, dawladda Alberta, Legal Aid Alberta iyo Law Society of Alberta waxay saxiixdeen heshiis cusub oo maamul oo shan sano ah, oo dhigaya fahamka la wadaago ee muhiimadda ay leedahay barnaamij gargaar sharci oo tayo sare leh, madax-bannaan oo waara.

Heshiiska cusub ee maamulka ayaa dhaqan galaya Sebtambar 6, 2024, wuxuuna socon doonaa ilaa Sebtambar 5, 2029. Marka ay heshiiskaan saxiixaan, dhammaan dadka ay khusayso waxa ay go'aansadeen in ay hubiyaan in nidaamka kaalmada sharci ee Alberta uu ahaado mid deggan oo uu sii wado buuxinta baahiyaha kuwa u baahan kaalmada dhanka sharciga ah. Heshiiska cusub wuxuu hoosta ka xariiqayaa sida ay uga go'an tahay dowladda Alberta inay hubiso helitaanka caddaaladda ee dadka reer Alberta, iyadoo la aqoonsanayo in kaalmada sharci ay adeeg muhiim ah u tahay dad badan oo reer Alberta ah oo wajahaya caqabado dhaqaale si ay u helaan taageero sharci.
