Video-delivery of ICS courses has been approved for the duration of the pandemic. Video-delivery courses including all group activities and discussions are equivalent to an in-class offering and may issue ICS Canada certificates for course completion.

** Two-day versions of the I-300 certificate are <u>not acceptable</u>, even if it displays a logo from one of the approved providers. I-300 Certificates must reflect a three-day course.



ICS Alberta Course Pre-requisites

Effective January 1, 2024



Not all training providers meet ICS Canada and/or AEMA training standards. For a list of Alberta ICS approved providers, see the reverse side. On-line I-200 courses may not be accepted by all organizations.

Effective January 1st, 2020, participants will be required to provide a copy of their pre-requisite certificates from approved ICS Canada providers in order to register or attend ICS Canada training.

There is a minimum time between I-200 to I-300 and I-300 to I-400 of five months. Instructors are not to accept students under the minimum five months without a written waiver from the Authority Having Jurisdiction.

TRAIN THE TRAINER COURSES

Instructors are required to have completed the ICS Canada course before teaching. Those with qualifications other than ICS Canada or on-line I-200 may be required to observe and/or participate in an ICS Canada approved course as a condition for instructor recognition.
