Awards: There are five [Premier's Council Awards](#): Gary McPherson Leadership Award, Marlin Styner Achievement Award, Youth Award, Margot Brunner Advocacy Award and Digital Impact Award. Descriptions for each award are included below.

Gary McPherson Leadership Award

This achievement award is presented to one individual Albertan each year who has demonstrated outstanding leadership or achievement in enriching the lives of persons with disabilities. The winner will exemplify the qualities and values of the late Dr. Gary McPherson who dedicated himself to furthering the ideals of equality and citizenship for all Albertans.

Dr. McPherson was instrumental in establishing the Premier's Council on the Status of Persons with Disabilities and served as its first chair. He volunteered extensively including 20 years in wheelchair sports administration. This award is based on core values such as trust, respect and courage, and bringing people together. Dr. McPherson's influence continues to have a positive impact on provincial and national policy and programs affecting persons with disabilities.

Marlin Styner Achievement Award

This achievement Award is presented to one individual Albertan each year who has a disability and who, through personal or professional achievements, has not allowed their disability to become a barrier in pursuing excellence.

During his life, the late Mr. Styner was firmly committed to improving the lives of persons with disabilities and led by example. A former member and Chair of the Premier's Council on the Status of Persons with Disabilities, he was an accomplished public speaker who shared his experiences about living with a disability and his passion for equal and fair treatment of all persons with disabilities.

Premier's Council Youth Award

This award is presented to an individual, or a team of individuals, **under the age of 25** who has/have made a significant contribution to creating an inclusive and accessible community for people with disabilities. This could include, but is not limited to, communities such as classrooms, neighbourhoods, city or provincial teams, and could be done through avenues such as education, advocacy, or volunteerism.

Margot Brunner Advocacy Award

This award is presented to an individual who demonstrates leadership in advocacy for the rights of individuals with disabilities. The winner of this award will demonstrate the characteristics and values of inclusion, equity and mentorship. This award is named after Margot Brunner, a longtime advocate for the disability community and executive director of a pan-disability organization. Premier's Council has created this annual award to honour Margot's passing in August 2023.

Digital Impact Award

This award is presented to an individual with a disability who has had a positive impact in an online environment or through other forms of digital media, where they have demonstrated and/or contributed to the celebration, education, and enrichment to the lives of Albertans with disabilities.

Each nomination form submitted must be for **one category only**. If you'd like to nominate an individual in more than one category, please submit separate nomination forms.

To nominate someone for one of the **Council Awards**, you must:

- **Fill out the nomination form** on the following pages, providing sufficient detail about the nominated individual, team, initiative, project or achievement. This includes a description of how the initiative, project or achievement developed or significantly enhanced a barrier-free, inclusive community for persons with disabilities.
- Include **two letters of support**. Include the letters with the signed nomination form.
- Include a **mini biography** of the nominee - maximum 240 words. If the nominee is selected to receive an award, the biography will be made available to the public.
