Instructions:

A completed return and the levy collected must be received by Tax and Revenue Administration (TRA) on or before the 28th day following the end of the period covered by the return. Filing of the return and payment of the tourism levy must be made on time to avoid a late filing penalty or interest. An operator registered on or after April 1, 2021 is required to file returns electronically online using Tax and Revenue Administration Client Self-Service (TRACS).
